# **Comprehensive Sex Education in Public Schools**

### A. Early Voting Begins on Tuesday through the 20th

- 1. Our vote is our voice.
- 2. The President, Vice President, U.S. Senators, U.S. Representatives.
- 3. State Senators, State Representatives, Judges, Sheriff, Railroad Commissioner, Constable, Tax Assessor-Collector.
- 4. At the very end are listed the Texas State Board of Education members and local ISD Board members.
  - a. These are often overlooked.
  - b. Who really cares?
- 5. Today, we will study a topic which is absolutely shocking.
  - a. It will change our thinking regarding the importance of these board members.
  - b. The devil is trying to infiltrate our public schools.
  - c. At the same time, he is trying to undermine the family and the importance of mothers and fathers.
  - d. 99% of the public are completely unaware.

### **B.** Where Do the Parties Stand on Sex Education in Public Schools?

- 1. The Democratic Party supports LGBTQ+ age appropriate sex education with a full range of family planning services.
- 2. The Republican Party recognizes that parents, not the government, are a child's first and foremost educators.
- 3. The Republican Party encourages teaching the Bible as an elective in public schools.
- 4. The Republican Party supports sexual risk avoidance education that sets abstinence until marriage as the responsible and respected standard of behavior.
- 5. The Republican Party opposes reshaping our schools and our entire society to fit the mold of an ideology alien to America's history and traditions.

#### C. Much Has Changed Since We Attended Public School

- 1. The devil is against whatever is Biblical.
- 2. That is what we are seeing with the Comprehensive Sex Education curriculum.
- 3. It is stunning to see what the state of California has done to defile our children and destroy our families.
- 4. Their K through 12 curriculum is unimaginable.
- 5. It has been adopted in one way or another in all 50 states and is now trying to infiltrate the State of Texas.

## D. What is California Teaching Their Students?

- 1. I have organized the information into these categories:
  - a. Contraceptive methods and abortion options
  - b. Gender identity training
  - c. Graphic sex
  - d. Consent
- 2. Contraceptive methods and abortion options
  - a. Students are given a wide range of information on various types of birth control with graphic illustrations.
  - b. Condoms and birth control pills are distributed without parental consent.
  - c. "It's smart to use a condom every time you have sex. Condoms help prevent sexually transmitted diseases and pregnancy. If you are 12 to 19 years old and live in California, find out where you can pick up free condoms or you may have the option to get condoms mailed to you. If you are worried about getting condoms mailed to your house and your parents opening your mailbox, you can have them mailed to a different address or you can pick up free condoms near you by searching our map."
  - d. They discuss the benefits of anal and oral sex as an alternative to avoid pregnancy.
  - e. Abortion is portrayed as a safe means of birth control as students are directed to the Planned Parenthood website that states: "There are two ways of ending a pregnancy: in-clinic abortion and the abortion pill. Both are safe and very common. If you are pregnant and thinking about an abortion, you may have lots of questions. We are here to help."
  - f. California started this five years ago and then Planned Parenthood took over the curriculum.
  - g. Planned Parenthood's goal is for girls to become so sexually active that they will have to have an average of three abortions in their lifetime (at costs ranging from \$500 to \$15,000).
- 3. Gender identity training
  - a. Three years ago, there were 90 different genders.
  - b. They now use LGBTQIA+ now, you get to define your own sexuality.
  - c. Students are introduced to multi-gender options.
  - d. Homosexual-bisexual-transsexual indoctrination without parental consent is offered, including off-campus pro-homosexuality counseling.
  - e. Students are taught in elementary school that gender is not strictly defined by biology and sexual anatomy.
  - f. The curriculum discourages gender words like male, female, mom and dad.
  - g. "Being Transgender is Perfectly Normal," is a recommended article written by a 19-year old.

- 4. "Who Are You? A Kid's Guide to Gender Identity" (K through 3)
  - a. "Babies can't talk, so grown-ups make a guess by looking at their bodies."
  - b. "Is it a boy or a girl? And for some people, there are more than just two choices. These are just a few words people use: trans, genderqueer, non-binary, gender fluid, transgender, gender neutral, agender, neutrois, bigender, third gender, two-spirit.
  - c. "The Gender Wheel will help 'YOU' determine what gender kids are!"
- 5. "My Princess Boy" (K through 3) "Once my Princess Boy wore a dress at his birthday party. He welcomed his friends to his home and he said, 'I am a Princess Boy!' He put on jewelry and he liked how pretty he looked....and waved his Princess Boy wand."
- 6. Graphic sex is portrayed in elementary, middle and high school.
  - a. In California, illustrations begin with Kindergarten.
  - b. By 10 years old, students are shown how to perform all manners of sexual gratification and intercourse.
  - c. Middle School and High School sex-ed becomes even more graphic.
  - d. Demonstrations are offered by website links, mostly to Planned Parenthood.
  - e. Parents can opt their children out of sexual education but prohibits them from opting their children out of materials that discuss gender, gender identity, gender expression and sexual orientation.
  - f. The California law prohibits abstinence-only education and any discussion of religious doctrine.
  - g. "Who You Are Straight, Lesbian, Gay, Bisexual, Transgender, Queer" along with cartoon illustrations of couples engaging in sexual acts.
- 7. Recommendation for Middle School students: "Text \_\_\_\_\_\_ to \_\_\_\_\_ to get sex info and life advice sent to you every week."

#### E. California Minor Consent Laws

- 1. "If you're a teen in California, you have rights. And that is what this section is about your legal rights to accessing sexual and reproductive health care including birth control (including emergency contraception), testing and treatment for STDs, pregnancy testing and prenatal care, abortion services and mental health services."
- 2. Minors of any age can receive birth control (except sterilization) without permission from their parents or their guardian. A provider can tell a parent or guardian only with the consent of the minor.
- 3. Minors of any age can receive pregnancy counseling including inpatient care without permission from their parents or their guardian. A provider can tell a parent or guardian only with the consent of the minor.
- 4. Minors of any age can receive an abortion without permission from their parents of their guardian. A provider can tell a parent or guardian only with the consent of the minor.
- 5. Minors of any age can be treated for STD's, contagious and reportable diseases without permission from their parents or their guardian. A provider can tell a parent or guardian only with the consent of the minor.

- 6. Minors 12 years and older can receive HIV Testing and assessed as competent to give informed consent without permission from their parents or their guardian. A provider can tell a parent or guardian only with the consent of the minor.
- 7. Minors 12 years or older can receive alcohol or drug counseling by a federally assisted treatment program without permission from their parents or their guardian. A provider can tell a parent or guardian only with the consent of the minor.
- 8. Minors of any age can receive sexual assault care. In most cases, an attempt to notify a parent or guardian must be made.
- 9. Minors 12 year or older can receive non-federally assisted treatment programs without permission from their parents or their guardian. An attempt to notify a parent or guardian must be made only when the provider believes it is appropriate.
- 10. Minors 12 years or older can receive outpatient mental health treatment without permission from their parents or their guardian. An attempt to notify a parent or guardian must be made only when the provider believes it is appropriate.

#### F. What is This All About?

- 1. The traditional family that God intended is being undermined.
- 2. The government is stepping in and taking the role of parents.
- 3. Recommended article called, "Breaking My Parents' Mold."
- 4. Biblical values are being made obscure.
- 5. It is the devil's plot to defile children and destroy families.

## G. Where Does the Bible Stand?

- 1. <u>Proverbs 22:6</u> "Train up a child in the way he should go: and when he is old, he will not depart from it."
- 2. <u>Proverbs 1:8-9</u> (NLT-96) "Listen, my son, to your father's instruction and do not forsake your mother's teaching. They will be a garland to grace your head and a chain to adorn your neck."
- 3. Proverbs 6:20-22 (AMPC) "My son, keep your father's [God-given] commandment and forsake not the law of [God] your mother [taught you]. Bind them continually upon your heart and tie them about your neck. When you go, they [the words of your parents' God] shall lead you; when you sleep, they shall keep you; and when you waken, they shall talk with you."
- 4. <u>Deuteronomy 4:9</u> (NKJV) "Only take heed to yourself, and diligently keep yourself, lest you forget the things your eyes have seen, and lest they depart from your heart all the days of your life. And teach them to your children and your grandchildren."
- 5. Deuteronomy 6:6-9 (NKJV) "And these words which I command you today shall be in your heart. You shall teach them diligently to your children, and shall talk of them when you sit in your house, when you walk by the way, when you lie down, and when you rise up. You shall bind them as a sign on your hand, and they shall be as frontlets between your eyes. You shall write them on the doorposts of your house and on your gates."

- 6. Ephesians 6:1-4 (AMPC) "Children, obey your parents in the Lord [as His representatives], for this is just and right. Honor (esteem and value as precious) your father and your mother—this is the first commandment with a promise—That all may be well with you and that you may live long on the earth. Fathers, do not irritate and provoke your children to anger [do not exasperate them to resentment], but rear them [tenderly] in the training and discipline and the counsel and admonition of the Lord."
- 7. Even the Republican Party knows better.... "Traditional marriage and family, based on marriage between one man and one woman, is the foundation for a free society and has for millennia been entrusted with rearing children and instilling cultural values." 2016 Republican Party Platform

# H. What is Happening in Texas?

- 1. In September 2020, the Texas State Board of Education had a "First Reading" after one year of expert reviews, committees, and testimony.
  - a. The Board took their first vote.
  - b. The new amendments were not approved.
  - c. It was defeated by a tight margin of 3.
- 2. Proposed amendments included:
  - a. Moving further away from abstinence education and toward an extreme and graphic "Comprehensive Sex Education."
  - b. Instruction about sexual orientation and gender identity to children as young as 11 down to pre-K students.
  - c. Discussing topics like sexual "consent" with elementary age children.
  - d. Promoting LGBTQ+ such as "gender identity" and "gender expression."
- 3. Texas State Board of Education members will take a final vote, November 17 through November 20.
- 4. The Fort Worth ISD is using the California version with adjustments.
  - a. You are not allowed to make copies of the curriculum.
  - b. Parents are not allowed to come to the school and review the contents.
- 5. In 2019, the Austin Independent School District unanimously approved the new Comprehensive Sex Education curriculum.
  - a. Each grade level has a different education plan and will include lessons about sexual orientation and gender identity beginning in the fifth grade.
  - b. In addition to sexual orientation, the proposed new curriculum includes lessons on pregnancy prevention, sexually transmitted diseases and consent.
  - c. Students will participate in activities designed to help them determine what abstinence means to them, understanding the effectiveness of a variety of contraception methods and ideas regarding single parenting and how to establish paternity.

### I. Our Call to Action

- 1. Eight of the 15 Texas State Board of Education members are up for re-election in November.
  - a. The back of the handout shows who they are.
  - b. It also reveals who voted for or against the radical agenda.
- 2. CONTACT the Texas State Board member who represents your district.
  - a. Even if they aren't up for re-election this November, make your voice heard.
  - b. Let them know you don't support the radical Comprehensive Sex Education curriculum and you do not want it in your district.
  - c. Sample copy is on the back of the handout.
- 3. CONTACT all of Texas State Board of Education members.
  - a. Their vote will affect all of our public-school children.
  - b. If the SBOE votes to accept this radical agenda, it will become the official state curriculum.
  - c. If an individual ISD wants to use another curriculum, they will have to pay for it.
- 4. VOTE for the ISD school board members in November.
  - a. Don't just vote for a random name.
  - b. Do the research necessary to make sure they stand against the Comprehensive Sex Education curriculum.
- 5. I am encouraging Pastors in the state of Texas to communicate this information to their congregations.
